Small Wastewater Systems

Septic system permits are required for the installation, repair or replacement of individual or commercial sewage disposal systems that treat less than 2,000 gallons of domestic sewage per day. If your facility treats more than 2,000 gallons of sewage per day, contact the Underground Injection Control (UIC) Program.

Permit Jurisdiction

This permit is to be used only for the construction of small wastewater facilities located in Campbell (commercial systems only), Carbon, Crook, Niobrara, Platte, and Weston Counties where DEQ is the permitting authority. If your septic system will be located in any other county, the permitting authority for that county may require different forms or additional information.

Small Wastewater System Permitting Instructions

- Step 1: Review the Small Wastewater Facility General Permit, which covers the installation, repair or replacement of individual or commercial sewage disposal systems that treat less than 2,000 gallons of domestic sewage per day.
- Step 2: Complete the short Small Wastewater Systems application package. A list of approved septic tank models and providers is available to help you select your tank. A table of design flow estimates for different types of buildings is available to help you calculate the volume of wastewater that your system needs to handle.
- Step 3: Fill out the forms (from the table below) for the type of leachfield system that you selected on page 14 of the application package. A table of equivalent areas for several brands and layouts of chambered systems is available to help you size your chamber system correctly.
- Step 4: Submit 3 copies of the application package and leachfield design sheets to the permitting authority.
- **Step 5:** Submit a **Certificate of Completion** when installation is complete.
- **Step 6:** Submit a **Transfer of Ownership** form if the ownership of this facility is transferred to another party.
